They include civil, political, economic, social and cultural rights. Human rights are inherent, inalienable, interdependent, and indivisible, meaning they cannot be granted or taken away, the enjoyment of one right affects the enjoyment of others, and they must all be respected.

Human rights legal framework. In international law, human rights obligations are those that states have undertaken by signing treaties, which are then ratified by national parliaments and enacted through changing the state’s practice. The 1948 Universal Declaration on Human Rights is by far the most widely accepted definition of human rights, encompassing civil and political as well as economic, social and cultural rights, all sharing the principles of universality and indivisibility.

In 1948 the United Nations adopted the Universal Declaration of Human Rights, which sets out the basic rights and freedoms that apply to everyone. It has become the most important document of its kind and is the basis of many legally-binding international human rights laws.
